Employee Benefits Selection (action item)

Mr. Kirk Fjelstul presented this item to the committee. He gave a brief background on the medical and ancillary (vision, dental, long-term disability and life insurance) coverages. The staff's recommendation is to approve the following Health benefits for TRRC employees:

- Medical coverage: Cigna Alternative 1, which includes a high deductible plan, and a Health Spending Account (HSA). The HSA includes "seed" money with employee only at \$500; EE and spouse at \$750; EE and children at \$750; and Family at \$1,000.
- Ancillary coverage:
 - Vision with Humana

• Dental, Long-term disability and Life insurance with Cigna.

Committee Chair Rivers advised that the recommendation was "spot on." FORMAL ACTION: Committee Chair Rivers made the motion that the Finance, Audit and Administration Committee approve the following health benefits for TRRC employees:
