### APPROVAL OF APRIL 22, 2021 MINUTES (action item)

Committee Chair Brown advised the members that the minutes from the April 22, 2021 meeting needed to be approved. Mr. Doug Hollberg made the motion to approve the April 22, 2021 meeting minutes; it was seconded by Mr. Lee Boone. Committee Chair Brown asked if there was any discussion; hearing none, he called for the vote and the motion carried unanimously.

### APPROVAL OF AGENDA (action item)

Committee Chair Brown advised that a motion was needed to approve the agenda. Mr. Hollberg made the motion to approve the agenda; it was seconded by Mr. Boone. Committee Chair Brown asked if there was any discussion; hearing none, he called for the vote and the motion carried unanimously.

## TRRC BROADBAND TASK FORCE UPDATE

Mr. Paul Jarrell presented this portion of the agenda. He advised the committee that the DCA GBDI recently provided a regional workshop (https://broadband.georgia.gov/webinars) and that GTA provided a technology summit (https://gta.georgia.gov/about-us/technology-summit-2021/session-descriptions). Mr. Jarrell revisited the information concerning the DCA GBDI Grant and gave a brief description of the grant. He also presented the broadband funding eligibility map, which reflected the served and underserved areas in our region. Mr. Jarrell spoke of the FCC Emergency Connectivity Fund Program in which the FCC has allocated \$7.17 billion. The program will provide funding for schools and libraries to purchase computer equipment, Wi-Fi hotspots and broadband connections to help students and teachers to access the internet for online learning. This program is a part of the \$1.9 trillion American Rescue Plan Act. Applicants must apply between July 1, 2021 and June 30, 2022; more information can be found at https://docs.fcc.gov/public/attachments/FCC-21-58A1.pdf . Mr. Jarrell also spoke of the FCC Emergency Broadband Benefit, which is a program geared to individuals that have an income that is at or below 135% of the federal poverty guidelines or the person participates in certain assistance programs, such as SNAP, Medicaid or Lifeline; approved to receive benefits under the free and reduced-price school lunch or breakfast program, including through the USDA Community Eligibility Provision in the 2019-2020 or 2020-2021 school year. # CENSUS UPDATE - APPORTIONMENT ONLINE MAP TOOL

Ms. Jeannie Brantley presented this portion of the agenda. She advised the members that the 2020 Census results have been added to the Online Mapping Tool. There has been an increase in Georgia's population since 2010; Georgia's population is now recorded at 10,711,908. It was noted that there is not a breakdown in 2020 Census information for the cities and counties at this time. There is no new information regarding redistricting, but Ms. Brantley will continue to monitor this situation and will provide updates to the committee. ## AMENDMENTS TO COMPREHENSIVE PLANS

Ms. Kim Dutton presented this portion of the agenda. She advised that the local governments are responsible for maintaining their plans to accurately reflect current community conditions as well as future goals and priorities. The local governments will determine when a plan amendment is necessary to address changing circumstances. Ms. Dutton provided the necessary steps that a local government must take in order to make any amendments to their comprehensive plans.

At the end of Ms. Dutton's presentation, Ms. Brantley advised the committee that Friday, May 28<sup>th</sup> is Ms. Dutton's last day with TRRC. Ms. Dutton will not be leaving our region as she has accepted employment as a planner with Coweta County. Ms. Brantley thanked Ms. Dutton for her work and wished her the best in her future endeavors.

# OVERVIEW ON THE AMERICAN RESCUE PLAN ACT

Mr. Brandon Lounsbury presented this portion of the agenda. He advised the committee of details of the American Rescue Plan Act (ARPA) which was enacted on March 11, 2021 as the third stimulus bill during the COVID-19 pandemic. The package included \$1.9 trillion to be available for a variety of state and federal programs as well as local governments. It was noted that \$350 billion in direct funding goes to states, counties and municipalities and it is required that the state pass on the funding to all local governments. Funds must be obligated by December 31, 2024 and completed by December 31, 2026. Mr. Lounsbury also provided information concerning how the funds are distributed, what the funds cover, other specified uses as well as the framework for eligible, non-specified use of funds, etc. He also included a table of expected county allocations for the TRRC area:

The trail, designed for hikers and mountain bikers, is 10.7 miles with four (4) creeks located in the vicinity. They invited the committee to attend the ceremony and to enjoy the trail.
